


### **BRINKER SALES AND REVENUE\***


### MENU PRICE / MIX DROVE DECREASE IN Q4 COGS


# Q4 SALES LEVERAGE LED TO LABOR DECREASE DESPITE HIGHER HOURLY LABOR, BONUS & SALARIES
