BRINKER INTERNATIONAL BOARD DECLARES COMMON DIVIDEND

DALLAS, Aug 23, 2007 — The Board of Directors for Brinker International, Inc. (NYSE: EAT) declared a quarterly dividend of \$0.09 per share on the common stock of the company. The dividend will be paid on Sept. 26, 2007 to shareholders of record as of Sept. 14, 2007.

At the end of fiscal year 2007, Brinker International either owned, operated, or franchised 1,801 restaurants under the names Chili's Grill & Bar (1,361 units), Romano's Macaroni Grill (241 units), On The Border Mexican Grill & Cantina (158 units), and Maggiano's Little Italy (41 units).
